

Arizona Suicide Prevention Coalition (AZSPC) Grief Labyrinth

Overview

The AZSPC Grief Labyrinth is a portable, meditative space designed to support individuals in their journey through grief and healing. This labyrinth provides a serene environment where participants can reflect, process emotions, and find peace. AZSPC offers this labyrinth on loan to organizations interested in providing a healing space for their communities.

Loan Structure

Loan Agreement

1. **Eligibility:** Organizations eligible to borrow the Grief Labyrinth include community groups, healthcare providers, schools, and non-profits focused on mental health and wellness.
2. **Duration:** The standard loan period is for one event, typically lasting 1-2 days. Extensions can be requested and will be considered based on availability.
3. **Cost:** The use of the Grief Labyrinth is free of charge. However, organizations are encouraged to make a donation to support AZSPC's efforts in maintaining the labyrinth and furthering suicide prevention initiatives.
4. **Reservation:** To reserve the Grief Labyrinth, organizations must complete a reservation form available on the AZSPC website or contact the AZSPC directly.
5. **Agreement:** A loan agreement must be signed by both the borrowing organization and AZSPC. This agreement outlines responsibilities, care guidelines, and return conditions.

Logistics

1. **Delivery and Setup:** AZSPC will coordinate the delivery and setup of the labyrinth. Borrowing organizations must provide a suitable location that is safe, accessible, and conducive to quiet reflection.
2. **Training:** AZSPC will provide a brief training session on setting up, maintaining, and facilitating the use of the labyrinth.
3. **Return:** The organization is responsible for ensuring the labyrinth is returned in good condition at the end of the loan period. AZSPC will coordinate the pickup.

Guidelines for Using the Labyrinth

1. **Respect the Space:** This is a sacred space meant for reflection and healing. Participants should maintain a respectful and quiet demeanor.

2. **Supervision:** The borrowing organization should provide supervision during open hours to ensure the labyrinth is used appropriately.
3. **Accessibility:** Ensure the labyrinth is accessible to all individuals, including those with disabilities.
4. **Free to Use:** Access to the labyrinth should be free for all participants. Donations are encouraged but not required. Suggested donation amounts can be communicated to participants, with collection managed by the borrowing organization.
5. **Personal Items:** Participants should not leave any personal items, mementos, or trash in the labyrinth. All belongings should be taken when leaving the space.
6. **Group Use:** For group visits or events, coordinate with AZSPC to ensure proper use and to avoid scheduling conflicts. Groups are encouraged to make a collective donation in appreciation of the space.
7. **Safety:** The labyrinth should be placed in a safe location. Be mindful of weather conditions and ensure participants' safety. In case of emergency, contact local authorities.

Arizona Suicide Prevention Coalition (AZSPC) Grief Labyrinth Loan Agreement

This Loan Agreement ("Agreement") is made and entered into as of [Date], by and between the Arizona Suicide Prevention Coalition ("AZSPC") and [Borrowing Organization] ("Borrower").

1. Purpose of Loan The AZSPC agrees to loan the Grief Labyrinth to the Borrower for the purpose of providing a healing and reflective space for individuals experiencing grief.

3. Delivery and Setup

- AZSPC will deliver and set up the Grief Labyrinth at [Borrower's Location].

- The Borrower agrees not to alter or modify the labyrinth in any way.
- The Borrower agrees to promptly notify AZSPC of any damage or issues that arise during the loan period.

6. Return of the Labyrinth

- The Borrower agrees to return the labyrinth in good condition at the end of the loan period.
- AZSPC will coordinate the pickup of the labyrinth from the Borrower's location.

7. Donations

- The Borrower may suggest donations to participants, with all donations collected to support AZSPC's initiatives.

8. Indemnification

- The Borrower agrees to indemnify and hold harmless AZSPC from any claims, damages, or liabilities arising from the use or misuse of the labyrinth.

9. Termination

- Either party may terminate this Agreement with written notice if the other party fails to comply with the terms of this Agreement.
- Upon termination, the Borrower agrees to return the labyrinth promptly.

10. Miscellaneous

- This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral.
- This Agreement may be amended only in writing signed by both parties.
- This Agreement shall be governed by and construed in accordance with the laws of the State of Arizona.
